NOTICE REGARDING BACKGROUND INVESTIGATION

the PNW Annual Conference of UMC may obtain information about you from a consumer reporting agency for volunteer screening purposes. Thus, you may be the subject of a "consumer report" and/or an "investigative consumer report" which may include, but is not limited to: employment and education verifications; social security number verification; criminal and civil court records; personal interviews; driving records; credit reports; and/or any other public records or any other information bearing on your character, general reputation, personal characteristics and trustworthiness. These reports may be obtained at any time after receipt of your authorization and, if you are selected, throughout your affiliation with the PNW Annual Conference of UMC. You have the right, upon written request made within a reasonable time after receipt of this notice, to request disclosure of the nature and scope of any investigative consumer report.

The report will be generated by **DATASOURCE** (located at 1200 South Outer Road, Blue Springs, MO 64015/816-875-5433) or another outside organization. The scope of this notice and authorization is all-encompassing, however, allowing the PNW Annual Conference of UMC to obtain from any outside organization all manner of consumer reports and investigative consumer reports now and, if you are selected, throughout your affiliation with the PNW Annual Conference of UMC to the extent permitted by law. As a result, you should carefully consider whether to exercise your right to request disclosure of the nature and scope of any investigative consumer report.

I agree that a facsimile ("fax") or photographic copy of this Authorization shall be as valid as the original.
